Leadership

Has top management taken accountability for the effectiveness of the OHSMS?	
Has top management established an Occupational Health & Safety Policy?	
Is the Occupational Health & Safety policy appropriate to the context of the organisation?	
Have objectives been established at relevant departmental & individual levels within your organisation?	
Has the organization assigned responsibilities and authorities in respect of the OHSMS?	

Planning

Does the organization follow a process that determines risks and opportunities?	
Have you identified and evaluated a process for hazard identification, and identified the risks and opportunities associated with adverse and beneficial impacts?	
Have the risks and opportunities been considered with regard to the context of the organization and the needs and expectations of interested parties?	
Have you determined and have access to your compliance obligations and determined how these apply?	
Have you established an action plan to address the identified risks and opportunities and determined how these specifically apply to the organization?	
Do you have plans in place to achieve Occupational Health & Safety objectives?	



Support

Has the organisation determined & provided the resources needed to establish, implement, maintain and continually improve the Occupational Health & Safety Management System. This should include people, Occupational Health & Safety and infrastructure requirements.	
Has the organization promoted awareness of Occupational Health & Safety management; so that all those working under the organization's control are aware of the requirements associated with their work and have the competence requirements been determined?	
Has the organisation ensured that those persons who can affect the performance of the Occupational Health & Safety Management System are competent on the basis of appropriate education, training or experience or taken action to ensure that those people can acquire the necessary competence?	
Has the organization planned, implemented and maintained a communication process both internally and externally taking into account compliance obligations and ensuring consistency with information generated by the Occupational Health & Safety Management System?	
Has the documented information required by the standard & necessary for the effective implementation and operation of the Occupational Health & Safety Management System been established?

Operation

Does the organisation have processes in place to establish, implement, control & maintain the Occupational Health & Safety Management System and to implement the actions to address risks & opportunities?	
Has the organization considered how it manages outsourced functions including ensuing that legal and other requirements are met? Do we have sufficient controls in place around outsourced functions?	

Has the organization established and implemented a process specifying how it will respond to potential Occupational Health & Safety Emergency situations?

Performance Evaluation

Have you determined:

- What needs to be monitored & measured?
- The methods for monitoring, measurement, analysis & evaluation to ensure valid results?

Have you established when the results from monitoring and measurement shall be analysed and evaluated?

Have you established and implemented a process to evaluate the organization's level of conformances with its compliance obligations, including recording the results?



Has a process for internal audit of the Occupational Health & Safety Management System been established?	
Has the management review process been established and implemented and does the output of the review include opportunities to improve the integration of the Occupational Health & Safety Management System into other business processes if required?

Improvement

Has the organisation determined and selected opportunities for improvement and implemented the necessary actions to achieve the intended outcomes of its Occupational Health & Safety Management System?	
Has the organisation appropriate processes for managing nonconformities and the related corrective actions?	
Has the organisation developed a mechanism for addressing the requirement to continually improve the suitability, adequacy and effectiveness of the Occupational Health & Safety Management System to enhance Occupational Health & Safety performance?
